Flag Salute

Attendance: Chair Jennifer Meyer, Supervisor Mona Mathews, Supervisor Jeff Whyte, and Supervisor Megan Bischel. Supervisor Paul Travis not in attendance.

Approve Minutes: April 9th meeting minutes:

4-H Student presentation:

A. Loralie Schwartz was in attendance and distributed to Board members a drawing of her Little library. Total cost for library to be built is \$200.00, she does have some items being Donated. Comp Plan:

A. Bischel CSM/103 S. Town Hall Rd./land division/Surveyor Eric Knauf: This CSM is taking 1 lot and making 2. Will take all buildings and put on 1 lot, 2nd lot is just land. This is Zoned A1. Lot 2 will be separate lot and sold to Anthony Bischel.

Park Commission:

- A. May 8th meeting update: Chair Jennifer Meyer and Anthony Bischel gave update. Garlic Mustard pulling will be at the Conservancy on May 15th and 22nd. Working on educational events at Sherman Creek Park and the Conservancy. Pavilion work is complete. Fred Belay and Tom Roach put some gravel at the entrance.

Fire Station #3:

A. Battalion Chief Eddy Yates distributed his report to Board members. Sunday, May 19th is family night at the Fire Station. Fire Department needs new tractor for ditch mowing.

Fire department would like to have a discussion regarding having the Town take care of mowing and snowplowing at Fire Station. Battalion Chief would also like the Town to put in a loafing shed in the back of the Fire Station to store all equipment that sits outside. These discussions will take place during budget hearing in November.

Roads:

- A. County Line Rd Project / Cedar Corporation: Dennis Mack from Cedar Corp was in attendance and handed out plans. Plans will be out for bids end of May. Work will not start before July 4th. Land acquisition needs to start.
- B. 6'-19' Culvert Inventory/Dennis Mack; Cedar Corporation: Dennis Mack had map to show culverts found in the Town. Culvert on Silver Mine needs to be inspected.
