Adopt Agenda: Chair Jennifer Meyer made a motion to adopt agenda. Supervisor Mona Mathews seconded. All voted yes, motion carried.

Approve Minutes: October 8th meeting minutes:

Supervisor Mona Mathews made a motion to approve. Supervisor Megan Bischel seconded the motion. All voted yes, motion carried.

CTH T: Intergovernmental agreement/EC CTY HWY Commissioner Jon Johnson: Jon Johnson Eau Claire Cty Hwy Commissioner was in attendance to go over Intergovernmental Agreement and answer any questions. The initial phase for the project for designing and planning is being billed to Town of Union for their percentage.

This Intergovernmental Agreement is a 3 – Phase Project for Cty Hwy T. Town of Union will be billed as each phase is completed. This is the first phase and will begin on the North-End of Hwy T by Hwy 29. Town of Unions cost will be \$40,000 approximately.

Supervisor Mona Mathews made a motion to approve the Intergovernmental Agreement as presented to the Board. Supervisor Megan Bischel seconded the motion. All voted yes, motion carried.

Excel Energy Presentation:

Oversized load permit: Excel Energy was not in attendance but Charlie Price from Edwards Moving was. Edward Moving will be transporting a large generator on Kane Rd. in Town of Union. This will happen between Now and January, not sure of exact date as it has not started transporting. Chippewa County has approved the permit to haul the generator along with Town of Wheaton on their specific roads. Chair Jennifer Meyer made a motion to approve the hauling of the generator on Kane Rd in Town of Union. Supervisor Megan Bischel seconded the motion. All voted yes, motion carries.

Comp Plan:

 Conditional Use Permit (CUP) The Pines Music Park / 2-day Live Music Event request August 15-16, 2025 – Mark Bischel from Pines Music Park was in attendance to answer any questions. This CUP is for a 2-Day Blue Grass Festival to be held in August. It will run from 5pm till midnight. Campers will move in Thursday before the event. Expected attendance around 3,000. Comp Plan committee had no issues with the CUP.

Supervisor Mona Mathews made a motion to approve the CUP for The Pines Music Park/2-day Event in August 2025. Supervisor Paul Travis seconded. All Board members voted yes except Supervisor Megan Bischel abstained. Motion carries.

 Conditional Use Permit (CUP) Indianhead Oil Co./Dennis and Kristin Arneson requesting Restaurant with drive-thru on Truax Lane. This CUP is for a Culvers Restaurant with Drive In. This Culvers will be similar to the one on Folsom. Gas Station will be demolished and building will be built in area to the West. Comp Plan committee had not issues with the CUP.

Chair Jennifer Meyer made a motion to approve the CUP for Indianhead Oil and Dennis and Kristin Arneson. Supervisor Mona Mathews seconded the motion. All voted yes, motion carries.
